

INCIDENT MANAGEMENT SITUATION REPORT
 SATURDAY, SEPTEMBER 16, 2000 - 0900 MDT
 NATIONAL PREPAREDNESS LEVEL III

CURRENT SITUATION:

Eight new large fires were reported, three each in the Southern Area and the Rocky Mountain Area, and two in the Eastern Great Basin. Crews reached containment goals on two fires in the Southern California Area, and one in the Southern Area. Initial attack activity was moderate throughout the United States. The majority of the western and southern states will experience high temperatures and dry conditions over the next few days. Very high to extreme fire indices were reported in Oregon, Washington, California, Idaho, Utah, Nevada, Montana, Wyoming, Arizona, Colorado, Kansas, Arkansas and Oklahoma.

SOUTHERN AREA LARGE FIRES:

ARBUCKLE, Oklahoma Division of Forestry. This fire burning in grass, cedar and oak is located 11 miles northwest of Ardmore, OK. Very active fire behavior was observed. There is a communications site and a watershed threatened. Rough, rocky terrain has made control difficult.

SKELETON, Oklahoma Division of Forestry. This fire is burning in heavy brush fuels five miles west of Mulhall, OK. One residence is confirmed lost. Control problems include heavy fuels and rough terrain.

PONTOTOC, Oklahoma Division of Forestry. This fire is burning one half mile north of Pontotoc, OK. One residence and three outbuildings were destroyed. Several homes were evacuated due to extreme fire behavior.

BILLY BELL, Oklahoma Division of Forestry. This fire is burning on Weyerhaeuser Timber Company Land 18 miles west of Broken Bow, OK. No new information was received.

AIRPORT, Oklahoma Division of Forestry. This fire is three miles northeast of Stigler, OK. No new information was received. This will be the last report unless new information is received.

ROCKY MOUNTAIN AREA LARGE FIRES:

NO FLESH, Pine Ridge Agency, BIA. This fire is located near Kyle, South Dakota. The cause of the fire is unknown. Aircraft helped support containment efforts.

PEARL, Routt National Forest. This fire is located 20 miles north of Steamboat Springs, Colorado. The fire is burning in spruce, fir, and logging slash. Spotting of up to 300 yards ahead of the fire has been observed.

ELDORADO, Fort Collins Dispatch Center Counties. This fire is burning west of Boulder, Colorado. The fire is burning in timber. Aircraft assisted in suppression efforts.

HARRIS, Santa Barbara County Fire Department. This fire is located south of Santa Maria, CA. Current threat is to residences, oil fields and ranches.

PARADISE, Angeles National Forest. This fire is near Castaic, CA. No new information was received. This will be the last report unless new information is received.

EASTERN GREAT BASIN AREA LARGE FIRES:

CLEAR CREEK COMPLEX, Salmon-Challis National Forest. A Type I Incident Management Team (Stam) is assigned. This complex consists of the Clear Creek, Marlin Springs, Full Circle and Sisters fires. The 3rd Battalion, 2nd Marines from Camp Lejeune, North Carolina, commanded by LTC Smith, is committed. High winds and low relative humidities caused torching and some runs within the perimeters. Crews continue with mopup and rehabilitation on all the fires.

LAVA HOT SPRINGS #3, Upper Snake River District, BLM. This fire burning in grass and sagebrush one mile north of Lava Hot Springs, ID. An electronics site was damaged. Dry fuels are hampering control efforts.

FONTENELLE, Bridger-Teton National Forest. This fire is 20 miles north of Kemmerer, WY. No new information to report.

SCF WILDERNESS, Salmon-Challis National Forest. Eleven wildland fires are currently burning within the Salmon Challis Wilderness Complex: Little Pistol, Indian Creek, Filly, Butts, Papoose, Parker, Packer Meadow, Shell Rock, Wilson Creek, Jackass and Jack Creek. No new information to report.

GREEN, Upper Snake River District, BLM. This fire is burning in sagebrush and timber 18 miles east of Rexburg, ID. Dry fuels are limiting control efforts.

NORTHERN ROCKIES AREA LARGE FIRES:

VALLEY COMPLEX, Bitterroot National Forest. A Type II Incident Management Team (Gauger) is assigned. These fires are seven miles south of Darby, MT. The complex consists of the Bear, Taylor, Taylor Spot, Hilltop, Razor, Fat and Mink fires. Fire behavior is still low and demobilization of resources continues.

SKALKAHO COMPLEX, Bitterroot National Forest. A Type II Incident Management Team (Hoff) is assigned. This group of fires is ten miles southeast of Hamilton, MT. Crews continue mopup and patrolling of internal hotspots.

MIDDLE FORK COMPLEX, Beaverhead-Deerlodge National Forest. A Type II Incident Management Team (Swope) is assigned. These fires are 30 miles southwest of Philipsburg, MT. The complex consists of the Falls Creek, Cougar Creek, Coyote Springs, Medicine Lake, Skalkaho Pass, Lick Creek and Cooper Creek fires. Crews are making good progress with completion of direct fireline, mopup and securing existing containment lines. Rehabilitation is progressing along the fire perimeter.

MUSSIGBROD COMPLEX, Beaverhead-Deerlodge National Forest. These fires are 12 miles northwest of Wisdom, MT. The complex includes the Mussigbrod and Maynard fires. A few interior hotspots were observed. Rehabilitation continued on all divisions.

ALDER CREEK, Lolo National Forest. This fire is 31 miles southeast of

Missoula, MT. Crews continued mopup and building direct fireline. Aerial observation reported a few hotspots within the perimeter. Demobilization of resources continues.

SOUTHWEST AREA LARGE FIRES:

BLOODGOOD, Gila National Forest. This fire is located five miles southwest of the Gila Cliff Dwellings. The fire has become very active due to high temperatures and dry fuels.

NAVAJO MT. 1, Navajo Area Office, BIA. No new information was received.

SIERRA, Gila National Forest. This lightning ignited wildland fire is being managed to accomplish resource objectives.

OUTLOOK:

*** FIRE WEATHER WATCH FOR INLAND COUNTIES OF THE FLORIDA PANHANDLE FROM NOON UNTIL SUNSET FOR POSSIBLE LONG DURATIONS OF LOW HUMIDITIES.***

Southern Texas and the Gulf Coast states can expect a northerly flow aloft and high pressure at the surface, keeping the region quite dry. High temperatures will be from the upper 70's to around 90. Minimum relative humidity will be 20 to 30 percent inland and 30 to 45 percent along the immediate coast. Expect northeast winds of 10-15 mph.

Across the west, a weak trough of low pressure will bring a slight chance of showers and thunderstorms to central Oregon, across central Idaho, and into western Montana. The remainder of the west will be sunny and warm under the influence of a large ridge of high pressure. High temperatures will be in the 70's and 80's in the north, to the 90's and 100's in the south. Minimum relative humidity will generally range from the teens to 25 percent, with some single digits in the driest areas. Winds across

most of the west will be southwest at 15 mph and the pacific coast could see some light northwest winds at 5-15 mph.
