

INCIDENT MANAGEMENT SITUATION REPORT
FRIDAY, OCTOBER 14, 2005 – 0530 MDT
NATIONAL PREPAREDNESS LEVEL 3

CURRENT SITUATION:

Initial attack activity was light nationally with 52 fires reported. One new large fire was reported in the Southwest Area. One large fire was contained in the Northern California Area. Very high to extreme fire indices were reported in Arizona, California, Montana, and Nevada.

A Presidential Disaster Declaration was issued for Hurricanes Katrina and Rita in Mississippi, Alabama, Louisiana and Texas. Two Area Command Teams (Ribar and Williams-Rhodes) are assigned.

Ribar's Team is at Foley, AL providing coordination for incident management operations in Mississippi for FEMA Region IV. Williams-Rhodes Team is coordinating relief operations in Louisiana and Texas (FEMA Region VI). The Marietta Mobilization Center in Marietta, GA continues to house and in-brief Incident Management Teams and other resources prior to assignment.

SOUTHERN AREA INCIDENTS / LARGE FIRES:

HURRICANE KATRINA SUPPORT, Federal Emergency Management Agency. Emergency Support Function (ESF) #4 at the state Emergency Operations Centers in Jackson, MS and Baton Rouge, LA are staffed.

Nine Type 2 Incident Management Teams (Dave Johnson, Larsen, Goheen, Allen Johnson, Stewart, Whalen, Carlson, LaFave, and Floyd) are assigned.

Dave Johnson: managing base camps at Gulfport and Vancleave, MS.

Larsen: managing the Holy Cross Base Camp under a unified command with New Orleans Fire Department and other fire departments, and is providing fire and emergency response to the City of New Orleans. The team is continuing to provide support to the St. Gabriel Mortuary Support Camp at St. Gabriel, LA. Demobilization will begin today.

Goheen: managing a mobilization center and base camp at Camp Beauregard, near Pineville, LA.

Allen Johnson: managing five distribution points in Hancock County from a base camp at Stennis Space Center, MS. A transfer of command to a Type 2 Incident Management Team (LaFave) will occur today.

Stewart: assessing timber damage and coordinating wildfire presuppression and initial attack planning in Hammond, LA. No new information was reported.

Whalen: managing a receiving and distribution center and supporting a mobilization center at Bossier City, LA. A transfer of command to a Type 2 Incident Management Team (Floyd) will begin today.

Carlson: managing the Jackson Support Base in the New Orleans French Quarter and supporting several satellite camps in southern Louisiana.

HURRICANE RITA SUPPORT, Federal Emergency Management Agency. Emergency Support Function (ESF) #4 at the state Emergency Operations Centers in Austin, TX is staffed.

Three Type 1 Incident Management Teams (Feser, Molumby, and Sexton) are assigned.

Feser: managing a receiving and distribution site in Lufkin, TX, a base camp in Kirbyville, TX, and supporting distribution operations in Jasper County, TX. A transfer of command to a Logistics Management Team has begun.

Molumby: supporting distribution centers and several emergency operations centers in three counties, and managing a base camp at Ford Park Arena, Beaumont, TX. Demobilization has begun.

Sexton: managing a 500 person base camp near the town of Cameron, LA and supporting the Lake Charles Regional Staging Area and several distribution sites at Lake Charles, LA. Demobilization will occur today.

SOUTHWEST AREA INCIDENTS / LARGE FIRES:

TED, Arizona State. This fire is 30 miles north of Wickenburg, AZ in brush and slash. Two structures are threatened. Moderate fire behavior with single tree torching was observed.

OUTLOOK:

Red Flag Warnings: For Los Angeles and Ventura Counties, California mountains and valleys above 1,000 ft. for very low humidity.

Fire Weather Watch: For inland areas of the Big Bend and panhandle areas of Florida, to southwest Alabama and southeast Mississippi for low relative humidity and above normal temperature.

Weather Discussion: High pressure over the west will give way to a strong low pressure system moving into the Pacific Northwest. This trough will bring gusty winds to portions of the west. Further south, a warm, dry offshore flow will continue over Southern California.

NO COMMUNICATION LINK WITH CREW MEMBERS, SUPERVISORS & ADJOINING FORCES

Watchout Situation #7 is a danger that must be mitigated by maintaining good communications while working on fires. Firefighters must constantly ask themselves the following questions as situations change on the fireline:

- Can communications be established?
 - Talk about how communications are set up on fires.
 - Review situations where communications were a problem and what was done to fix the problem.

- Is the communication triangle complete?
 - Review the communication triangle and where it comes up in the "10 Standard Fire Orders" and the "18 Watchout Situations."
 - Discuss ways that firefighters can maintain the communication triangle on the fireline.
