**Sweat Farm Road**, Georgia Forestry Commission. IMT 2 (Floyd). NIMO (Ferguson). Started on private land 10 miles southeast of Waycross, GA. Southern rough and timber. Spotting, 100 foot flame lengths and moderate rates of spread. Numerous residences remain evacuated. Highways 82, 84 122 and US 1 impacted by smoke.

**Big Turnaround**, Okefenokee NWR. IMT 2(Wilder). Ten miles southeast of Waycross, GA. Southern rough, timber and gallberry. Torching and crowning. Highway 84 closed.

**Black Aggie**, Oklahoma DOF. Started on private land seven miles southeast of Locust Grove, OK. Timber understory. Moderate fire activity. Watershed threatened. Increased in acreage due to more accurate mapping.

**Carnsaw**, Ouachita NF. Ten miles northeast of Broken Bow, AR. Hardwood litter. Minimal fire activity. No further information received.

**Workman Mtn.**, Oklahoma DOF. Started on private land six miles southeast of Stilwell, OK. Uphill runs and 15 foot flame lengths. Watershed threatened.

**Lukin Ridge**, Oklahoma DOF. Started on private land six miles south of Jay, OK. Moderate intensity with spotting. Watershed and wildlife habitat threatened.

**Burns Lake**, Big Cypress National Preserve. Eight miles east of Ochopee, FL. Southern rough. No new information.

**Potato Hill**, Ouachita NF. Fourteen miles west of Danville, AR. Pine and hardwood litter. Backing and flanking fire. Last narrative report unless significant activity occurs.
