Lonesome Complex, Rogue River NF. IMT 1 (Pendleton). Twelve miles east of Prospect, OR. Timber. Moderate fire activity with torching and short-range spotting. Historical structures threatened.

Gnarl Ridge, Mt. Hood NF. IMT 2 (West). Ten miles south of Parkdale, OR. Timber. Surface fire. Structures threatened.

Kitson, Willamette NF. IMT 2 (Rapp). Seven miles southeast of Oakridge, OR. Timber. Minimal fire behavior.

Wizard, Deschutes NF. Eighteen miles northwest of Sisters, OR. Ponderosa pine. Isolated crown runs with short-range spotting.

Horseshoe, Deschutes NF. Twenty-five miles southeast of Lapine, OR. Timber with brush and grass. Minimal fire activity.

Predictive Services Discussion: Mainly warm and dry conditions will be in place over much of the country, with a few areas of showers and thunderstorms. Moderate to strong wind and rain will accompany a front moving through northern Minnesota. Some scattered thunderstorm activity is expected in the four corners states during the afternoon. Pockets of heavy rain and potential flooding is expected along the Appalachian Range from western South Carolina northward through Virginia, as a tropical system attempts to organize.
