Sweat Farm Road, Georgia Forestry Commission. IMT 2 (Floyd) and NIMO (Ferguson). Started on private land 10 miles southeast of Waycross, GA. Southern rough and timber. Spotting, torching, crown fire and high rates of spread. City of Folkston threatened. Evacuation of portions of Charlton County in effect, and county schools closed.

Big Turnaround Complex, Okefenokee NWR. IMT 2 (Wilder). Ten miles southeast of Waycross, GA. Southern rough, timber and gallberry. High rates of spread with multiple heads. Timber plantations threatened.

Roundabout, Georgia Forestry Commission. Started on private land four miles west of Pearson, GA. Southern rough and timber. Long range spotting. Residences threatened.

Candy Killer, Oklahoma DOF. Started on private land four miles south of Stilwell, OK. Hardwood litter. Short range spotting. Structures and a watershed threatened.

Pinnacle, National Forests in North Carolina. IMT 2 (Raley). Fifteen miles east of North Cove, NC. Hardwood litter and timber. Burning in wilderness area. No further information.

Knee Knocker Swamp, Georgia Forestry Commission. Previously reported. Two miles northwest of Nahunta, GA. Southern rough. No new information.

Burns Lake, Big Cypress National Preserve. Eight miles east of Ochopee, FL. Southern rough. No new information. Last report unless new information is received.

Two Sided, Eglin Air Force Base. Two miles south of Holt, FL. Southern rough. No new information. Last report unless new information is received.

The Pitt, Minnesota DNR. Two miles northwest of Pitt, MN. Timber. Running fire. Structures threatened and road closures in effect.

Pioneer, Chequamegon-Nicolet NF. Five miles northeast of Cable, WI. Timber. Spotting. Structures threatened and evacuations in place.

Juneberry, Minnesota DNR. Twelve miles northwest of Badger, MN. Grass and brush. Fire is being monitored. Structure protection in place.

Baraga Bump, Ottawa NF. Seven miles northeast of Sidnaw, MI. Timber. Extreme fire activity. Evacuation in effect.

Reiner, Minnesota DNR. Seven miles northeast of Grygia, MN. Grass. No further information.

Benville, Minnesota DNR. Eight miles northeast of Grygia, MN. Timber and brush. No further information.

Hamre, Minnesota DNR. Five miles southwest of Fourtown, MN. Brush and grass. Structure protection in place. No further information.

SPOT WEATHER FORECAST

Spot weather forecasts should be requested for those fires that have potential for extreme fire behavior, exceed initial attack, or are located in areas where Red Flag Warnings have been issued.

● Basic elements needed for a spot weather forecast include:

- Name of fire and management agency
- Request time and date
- Location by ¼ section
- Drainage name
- Exposure
- Size
- Elevation (top and bottom)
- Fuel type
- Fire character (ground, crown, etc.)
- Weather conditions (place, elevation, observation time, wind direction, wind velocity, dry bulb, wet bulb, remarks)
