**Egley Complex** (six fires), Burns Fire Zone, Malheur NF. IMT 1 (Pendleton). Ten miles north of Riley, OR. Timber litter. Active fire behavior with spotting and torching. Numerous structures remain threatened.

**Ball Point**, Mt. Hood NF. IMT 2 (Goheen). Twenty-three miles southwest of The Dalles, OR. Hardwood litter. Short range spotting with isolated torching. Structures threatened.

**Horse Heaven Complex** (four fires), Southeast Washington, DNR. Washington IMT 2 (LaFave). Thirty miles southwest of Prosser, WA. Grass and sage. Running fire. Reduction in acreage due to more accurate mapping.

**Calamity Complex** (six fires), Malheur NF. Transfer of command from IMT 2 (West) back to local unit today. Sixteen miles southeast of Seneca, OR. Timber and grass. Creeping and smoldering. Reduction in acreage due to more accurate mapping.

**Monument Complex**, Umatilla NF. IMT 2 (Batten). Five miles north of Monument, OR. Timber and grass. Running fire with heavy spotting and torching. Power lines, community and structures threatened.

**WSA Lightning Complex** (twenty-seven fires), Warm Springs Agency, BIA. IMT 2 (Jennings). Twenty-one miles southwest of Warm Springs, OR. Timber, grass and brush. Long range spotting and group tree torching. Structures threatened.

**Juniper Reservoir**, Vale District, BLM. Five miles west of Vale, OR. Brush and slash. Running, torching and backing fire. Several residences remain threatened. Road closures remain in effect.

**Fossil Creek**, Prineville District, BLM. Forty miles northwest of John Day, OR. Grass and sage. Active fire behavior. Structures threatened.

**Juniper Canyon**, Vale District, BLM. Nineteen miles east of Umatilla, OR. Brush. No new information.

**Black Rock**, Prineville District, BLM. Ten miles southeast of Clarno, OR. Grass and sage. Active fire behavior.

**Cottonwood**, Northeast Oregon, Pendleton Unit, DOF. Oregon IMT (Savage). Thirty miles northeast of Wallowa, OR. Timber and grass. Extreme fire behavior.

**Stove Pipe**, Prineville District, BLM. Eighteen miles south of Fossil, OR. Grass and sage. Running, isolated torching and backing fire.

**Ahorn**, Lewis and Clark NF. FUMT (Weldon). Thirty miles west of Augusta, MT. Timber litter. Short crown runs with sustained ground fire. Back country evacuations and partial trail closures initiated. Structures threatened.

**Fool Creek**, Lewis and Clark NF. FUMT (Svalberg). Thirty miles northwest of Choteau, MT. Timber litter. Short crown runs with group torching and spotting. Structures threatened.

**Salt Lick**, Bridger-Teton NF. IMT 2 (Suwyn). Twenty-five miles north of Pinedale, WY. Timber. Isolated torching and creeping. Road closures in effect. Precipitation occurred over the fire area yesterday.

**Black Pine 2**, Sawtooth NF. IMT 2 (Grant). Started on private land eleven miles southeast of Malta, ID. Grass, brush and juniper. Torching and backing fire. Structures remain threatened.

**Tongue Complex** (three fires), Boise District, BLM. IMT 2 (Johnson). IMT also managing the Boulder Creek fire. Forty-five miles south of Silver City, ID. Brush, grass and juniper. Moderate fire behavior. Structures remain threatened.

**Boulder Creek**, Boise District, BLM. Eight miles south of Silver City, ID. Grass, brush and juniper. Minimal fire behavior. Structures remain threatened.

**Milford Flat**, Southwest Area, Utah State Division of Forestry Fire & State Lands. IMT 1 (Muir). Three miles north of Milford, UT. Grass and brush. Isolated torching and creeping.

**East Zone Complex** (two fires), Payette NF. IMT 2 (Heintz). Twenty-five miles northeast of McCall, ID. Timber and grass. Moderate fire behavior with running and short range spotting. Structures threatened.
