Area Command Team (Zimmerman) is assigned to assist the Northern Rockies with analyzing assessments for long duration fires and emerging incidents.

Jocko Lakes, Flathead Agency, BIA. IMT 1 (Wilcock). Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole pine. Creeping with occasional single and group tree torching. Community of Seeley Lake and numerous structures threatened. Evacuations in effect.

Chippy Creek, Northwestern Land Office, Montana DNR. IMT 2 (Raley). IMT 1 (Bennett) ordered. Forty-two miles southwest of Kalispell, MT. Timber, dead and down lodgepole and logging slash. Torching with upslope crowning. Structures threatened. Evacuations in effect.

Skyland, Flathead NF. IMT 1 (Pendleton). Thirty-two miles east of Kalispell, MT. Timber and grass. Torching and occasional short duration crown fires. Structures threatened.

Rattlesnake, Nez Perce NF. IMT 2 (Secret and Kusicko). Twenty-five miles south of Elk City, ID. Timber and grass. Moderated fire activity with short crown runs. Community of Comstock and outlying structures threatened.

Ahorn, Lewis and Clark NF. IMT 1 (Whitney). Thirty miles west of Augusta, MT. Timber. No sustained fire activity. Structures threatened. Evacuations in effect. Precipitation occurred over the fire area yesterday.

Sawmill Complex (three fires), Lolo NF. IMT 2 (Heintz and Turman). Twenty-two miles southeast of Missoula, MT. Timber. Active fire behavior with significant uphill runs, single and group tree torching and backing upwind. Structures threatened. Precipitation occurred over parts of the fire area yesterday.

Brush Creek, Flathead NF. IMT 2 (Koehler). Twenty-five miles west of Whitefish, MT. Timber. Active surface fire with isolated torching. Structures threatened. Evacuations in effect.

Tin Cup, Bitterroot NF. IMT 2 (Kaage). Four miles west of Darby, MT. Timber and logging slash. Minimal fire activity. Structures threatened. Evacuations in effect.

Rombo Mountain, Bitterroot NF. FUMT (Svalberg). Eighteen miles south of Darby, MT. Bug-killed timber. Single and group tree torching with short crown runs and spotting. Structures threatened.

Fool Creek, Lewis and Clark NF. Thirty miles northwest of Choteau, MT. Timber and snags. Creeping and smoldering. Structures threatened. Evacuations in effect.

Meriwether, Helena NF. IMT 1 (Oltrogge). Thirty-seven miles northwest of Helena, MT. Timber, brush and grass. Active ground fire. Structures threatened.

Poe Cabin, Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Sciacca). Twenty-three miles southwest of Grangeville, ID. Timber and grass. Smoldering, creeping, and backing fire with occasional torching.

Bridge, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber. Smoldering and creeping with occasional single tree torching.

Goodale, Miles City Field Office, BLM. Fifty-four miles southwest of Miles City, MT. Timber, sage brush and grass. Wind-driven fire.

Wicked Creek, Gallatin NF. Twenty-seven miles south of Livingston, MT. Timber. Active crowning and short range spotting. Structures threatened. Evacuation in effect.

Jones, Miles City Field Office, BLM. Ten miles southeast of Miles City, MT. Grass. Wind-driven fire.

Pattengail Creek, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber with dead and down fuels. Group torching.

Conger Creek, Lolo NF. Twenty miles north of Ovando, MT. Timber. Group torching.

Lost Creek, Crow Agency, BIA. Six miles southeast of Pryor, MT. Timber and grass. No new information.

Garceau, Flathead Agency, BIA. Fifty-five miles south of Whitefish, MT. Timber and grass. No new information.

Chimney Complex, Craig Mountain Area Office, Idaho Department of Lands. Nineteen miles south of Lewiston, ID. Timber and grass. No new information.

Area Command Team (Loach) is assigned to manage large fires for the Boise and Payette National Forests.

Cascade Complex (six fires), Boise NF. IMT 1 (Broyles). Three miles northeast of Cascade, ID. Timber. Extreme fire behavior with crown fire runs, torching, and long-range spotting. Community of Warm Lake and power lines threatened. Evacuations in effect and Warm Lake Highway is closed.

East Zone Complex (three fires), Payette NF. NIMO (Ferguson). Thirty miles northeast of McCall, ID. Timber, brush and grass. Surface fire with isolated torching, short-range spotting, creeping and smoldering. Communities of Secesh and Warren, historic sites and bridges threatened. Evacuations in effect.

Shower Bath, Salmon-Challis NF. IMT 2 (Saleen). Eighteen miles northwest of Challis, ID. Timber with heavy dead and down fuels. Active fire with torching, crowning and short-range spotting. Structures threatened.

Landmark Complex (two fires), Boise NF. IMT 2 (Suwyn). Thirty-four miles southeast of McCall, ID. Timber. Active surface fire with torching, creeping and smoldering. Communities of Stibnite threatened.

Hardscrabble, Bridger-Teton NF. Twenty-six miles northwest of Dubois, WY. Timber. Wind driven runs with short-range spotting.

Shoestring, Twin Falls District, BLM. Five miles south of Gooding, ID. Grass and brush. Active fire behavior.

Cleveland Hill, Idaho Falls District, BLM. Thirteen miles northeast of Preston, ID. Brush. Extreme fire behavior with spotting. Structures threatened.

Middle Fork Complex (three fires), Boise NF. IMT 2 (Lund). IMT also managing the Trapper Ridge WFU. Fifteen miles northeast of Garden Valley, ID. Timber and brush. Torching, moderate range spotting and smoldering.

Trapper Ridge, Boise NF. Twenty-eight miles northeast of Idaho City, ID. Timber. Torching, creeping and smoldering.

Krassel Complex (seven fires), Payette NF. FUMT (Ourada/Soper). Forty-four miles northeast of Yellow Pine, ID. Timber, grass and heavy dead and down fuels. Active fire behavior with group tree torching and short crown runs.

Granite Creek, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber with heavy dead and down fuels. No further information received.
