**San Pedro**, Socorro District, New Mexico State Forestry. Two miles east of San Antonio, NM. Salt Cedar, brush & grass. Smoldering with isolated flare-ups.

**Center Peak**, Socorro District, New Mexico State Forestry. Twelve miles west of Animas, NM. Shrubs & short grass. Active fire behavior.
