Lone Oak, Cherokee National Forest. One mile southwest of Johnson City, TN. Hardwood litter. Running, torching and backing fire. Residences threatened.

Buck Horn Ranch, Texas Forest Service. Started on private land three miles southeast of Asherton, TX. Shrubs and grass. Wind driven fire with spotting. No further information received.

Byas Springs, Texas Forest Service. Started on private land twenty miles northwest of Kerrville, TX. Grass and brush. Wind driven fire. Residences threatened.

Bombing Range 15, National Forests in Florida. Twelve miles northeast of Altoona, FL. Brush and pine. Smoldering.

Myakka Cut, Florida DOF. Five miles north of Clewiston, FL. Grass. Smoke impacting Highway 27. Moderate rates of spread.

Grassy Island, Florida DOF. Three miles north of Clewiston, FL. Grass. Moderate rates of spread.
