A NIMO Team (Custer) is assigned as a planning and operational group in support of the National Multi-Agency Coordinating Group at Boise, ID.

Eight MAFFS C-130 air tankers are supporting the State of California. All aircraft are based at McClellan Airport in Sacramento California. The Mission Commander is LTC Roger Williams, 145th Air Wing Air National Guard, North Carolina. Three aircraft are provided by the 145th Airlift Wing, Charlotte, North Carolina, three from the 302nd Airlift Wing, Colorado Springs, CO and two from the 153rd Airlift Wing, Cheyenne, Wyoming.

On June 29, a firefighter assigned to the Walla Valley fire in Grand Canyon National Park was fatally injured when the EMS helicopter he was aboard crashed near Flagstaff, AZ. The firefighting community extends condolences to the family and friends of the deceased.

Zimmerman's Area Command Team is providing planning and incident management support to the Shasta-Trinity National Forest. Lohrey's Area Command Team is managing large fire complexes on the Lassen National Forest. Gage's NIMO Team is supporting the ONCC Multi-Agency Coordinating Group.

**BTU Lightning Complex** (17 fires), Butte Unit, Cal Fire. Cal Fire IMT 1 (Lewin). Twenty-seven miles north of Yuba City, CA. Timber, brush and logging slash. Active fire behavior. Numerous residences and structures threatened. Precautionary evacuation advisories have been issued for several communities.

**SHU Lightning Complex** (7 fires), Shasta-Trinity Unit, Cal Fire. Cal Fire IMT 1 (Kerschen). Shasta and Trinity counties, CA. Timber, brush and grass. Extreme fire behavior with backing and slope-driven runs. Platina, Keswick, Corman Ranch and power generation system threatened. Evacuation orders in effect.

**Whiskeytown Complex** (2 fires), Whiskeytown National Recreation Area, NPS. IMT 2 (McNitt). Twelve miles west of Redding, CA. Timber and brush. Backing with short uphill runs. Communication towers, power lines, and recreation infrastructure threatened.

**Lime Complex** (40 fires), Shasta-Trinity NF. IMT 1 (Opliger). Fourteen miles west of Hayfork, CA. Timber. Active backing and flanking fire with short uphill runs and spotting. Numerous structures, ranches and youth camps threatened.

**Iron Complex** (6 fires), Shasta-Trinity NF. IMT 1 (Broyles). One mile north of Junction City, CA. Heavy timber, brush and grass. Moderate fire activity with wind-driven runs. Communities of Hawkins Bar and Trinity Village threatened. Highway 299 has temporary closures and restricted traffic flow.

**MEU Lightning Complex** (12 fires), Mendocino Unit, Cal Fire. Cal Fire IMT 1 (Waterman). Mendocino County, CA. Timber and grass. Backing fire with slope and wind driven runs. Utility infrastructure and numerous residences threatened. Ten communities threatened. Evacuations in effect.

**Canyon Complex** (17 fires), Plumas NF. IMT 1 (Pincha-Tulley). Sixteen miles northeast of Paradise, CA. Timber. Increased fire activity with wind-driven runs. Residences and archeological sites threatened. Road closures in effect.

**American River Complex** (3 fires), Tahoe NF. IMT 1 (Summerfelt). Eleven miles northeast of Foresthill, CA. Timber, brush and chaparral. Moderate to intense surface fire with short crown runs and short-range spotting. Watershed, power lines and residences threatened.

**Yuba River Complex** (3 fires), Tahoe NF. IMT 2 (Joseph). Thirteen miles northeast of Nevada City, CA. Timber and brush. Backing fire. Several communities, hydroelectric facilities and recreation sites threatened.

**Mad Complex** (4 fires), Six Rivers NF. Humboldt County, CA. Timber, brush and grass. Active to moderate fire behavior. Residences threatened.

**Hell's Half Complex** (2 fires), Six Rivers NF. IMT 2 (Secret). Eight miles southwest of Burnt Ranch, CA. Timber. Active fire with group tree torching. Structures threatened.

**Ukonom Complex** (3 fires), Six Rivers NF. IMT 2 (Lund). Ten miles east of Orleans, CA. Timber. Increased surface fire activity with isolated torching. Structures threatened. Reduction in acreage due to more accurate mapping.

**Cub Complex** (2 fires), Lassen NF. IMT 2 (Batten). Sixteen miles southwest of Chester, CA. Timber. Short uphill runs, isolated torching, group tree torching and short-range spotting. Structures and roads threatened. Highway 32 closed for burn out operations.

**Corral**, Lassen-Modoc Unit, Cal Fire. IMT 1 (Larsen). Twenty-three miles west of Termo, CA. Timber. Moderate fire activity.

**Yolla Bolly Complex** (17 fires), Mendocino NF. IMT 2 (Harvey). Twenty-four miles southwest of Chico, CA. Chaparral, timber and grass. Active running fire with spotting. Yolla Bolly Middle Eel Wilderness area closed. Structures threatened.

**Siskiyou Complex** (3 fires), Klamath NF. IMT 2 (Paul). Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Increased rates of spread with short uphill runs and occasional torching. Campground and residences threatened.

**Alps Complex** (13 fires), Shasta-Trinity NF. IMT 2 (Soper). Twenty miles northwest of Junction City, CA. Timber and brush. Moderate fire activity with short crown runs. Residences threatened.

**Soda Complex** (3 fires), Mendocino NF. IMT 2 (Heintz). Fifteen miles northwest of Upper Lake, CA. Chaparral, mixed conifer and oak woodlands. Group torching and short uphill runs. Residences threatened.

**TGU Lightning Complex** (1 fires). Tehama-Glenn Unit, Cal Fire. Tehama County, CA. Chaparral. Slow rates of spread.

**Humboldt Complex**, Humboldt-Del Norte Unit, Cal Fire. Humboldt County, CA. Timber, slash and grass. Slow rates of spread. Numerous residences threatened.

**Basin Complex**, Los Padres NF. IMT 1 (Dietrich, Molumby and McGowan). Five miles southeast of Big Sur, CA. Timber, brush and slash. Backing and creeping. Numerous residences threatened. Evacuations in effect. Hwy 1 closed.

**Indians**, Los Padres NF. Unified Command between IMT 1 (Molumby) and Cal Fire IMT 1 (Hutchinson). Eighteen miles west of King City, CA. Timber, chaparral and grass. Creeping with slope-driven short runs. Numerous structures and cultural resources threatened. Voluntary evacuation recommendation in effect for Arroyo Seco.

**Oliver**, Merced-Mariposa Unit, Cal Fire. Cal Fire IMT 1 (Hodson). Twelve miles east of Mariposa, CA. Timber, heavy brush and downed fuels. Backing and flanking with interior runs. Numerous structures threatened.

**Piute**, Sequoia NF. Unified Command between IMT 2 (Smith) and Kern County FD, FS and BLM. IMT 1 (Hoff) also assigned. Seventeen miles northeast of Caliente, CA. Timber. Extreme fire behavior with high rates of spread and torching. Structures threatened. Evacuations in effect.

**North Mountain**, Stanislaus NF. IMT 2 (Woychak). Seven miles northeast of Groveland, CA. Chaparral and timber. Backing and creeping fire with short runs and torching. Numerous residences and lookout tower threatened.

**Silver Complex** (2 fires), Sierra NF. Twelve miles southeast of Mariposa, CA. Timber. Moderate fire activity.

**Clover**, Sequoia NF. IMT 2 (Johnson). Thirty-two miles north of Weldon, CA. Timber and brush. Backing and creeping fire with isolated torching and spotting. Residences threatened.

### **Escape Routes**

An escape route is a preplanned and understood route to reach a safety zone.

- What are the primary concerns in choosing an escape route?
  - - Select the closest, least obstructed route.
    - Plan for more than one escape route.
    - Avoid an uphill escape.
    - Scout and clearly mark the route for visibility (aids during smoky situations or night operational periods).
  - - Determine escape time--consider slowest person, fatigue, and temperature factors.
    - Continuously reassess the situation with regard to work progress and additional resource arrivals.
    - Assure all line personnel are familiar with escape routes.
