Area Command Team (Lohrey) is managing fire complexes on the Shasta-Trinity and Mendocino National Forests. The Team will be released today. NIMO Team (Custer) is assigned to the Shasta-Trinity National Forest.

Iron and Alps Complexes (3 fires), Shasta-Trinity NF. IMT 1 (Molumby). One mile north of Junction City, CA. Timber, brush and grass. Active flanking and backing fire with short uphill runs, torching creeping and smoldering. Numerous residences, structures and powerlines threatened.

Siskiyou/Blue 2 Complex (2 fires), Klamath NF. Transfer of command from IMT 1 (Wilcock) to IMT 2 (Paul) tomorrow. Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with timber litter. Backing and flanking with occasional torching. Cultural sites threatened.

Panther (2 fires), Klamath NF. IMT 2 (Harvey). Fourteen miles southwest of Happy Camp, CA. Timber and brush. Active fire behavior with short runs and isolated torching. Recreational areas closed.

Yolla Bolly Complex (3 fires), Mendocino NF. IMT 2 (Blume). Forty-seven miles southwest of Redding, CA. Timber. Active fire behavior with occasional torching.

Bear Wallow Complex (2 fires), Klamath NF. FUMT (Beckman). Confine/contain management strategy. Thirteen miles southeast of Happy Camp, CA. Timber and brush. Minimal fire behavior.

Ukonom-South Complex, Six Rivers NF. Transfer of command from IMT 1 (Wilcock) to FUMT (Beckman) today. Ten miles east of Orleans, CA. Timber. Backing fire with creeping, smoldering and isolated torching. Structures and cultural sites threatened.

Canyon Complex (2 fires), Plumas NF. Sixteen miles northeast of Paradise, CA. Timber. Minimal fire behavior.

Gnarl, Mt. Hood NF. IMT 2 (West). Twenty-four miles south of Hood River, OR. Timber. Backing fire with individual tree torching. Structures threatened. Reduction in acreage due to more accurate mapping.

North Fork, Umpqua NF. IMT 2 (Batten). Twenty-six miles northeast of Glide, OR. Timber. Spotting, creeping and smoldering. Recreational areas and road closures in effect.

Bridge Creek, Ochoco NF. IMT 2 (Rapp). Seven miles southwest of Mitchell, OR. Logging slash. Group torching, short uphill runs and short-range spotting. Structures, historic and cultural sites threatened.

Ochoco Fire Use – WFU, Ochoco NF. FUMT (Reidy). Ten miles southwest of Dayville, OR. Timber. Group tree torching and crown runs.

Jack Creek, Okanogan/Wenatchee NF. FUMT (Bonefeld) ordered. Confine/contain management strategy. Thirteen miles southwest of Leavenworth, WA. Subalpine timber. Active fire behavior with torching, short crown runs and spotting. Cultural sites threatened. Area and trail closures in effect.

Snow Creek, Deschutes NF. IMT 2 ordered. Twenty-seven miles southwest of Bend, OR. Timber. Rapid rates of spread and torching. Structures, powerlines, and campgrounds threatened.

North Pole Ridge, Prineville District, BLM. Confine/contain management strategy. Ten miles north of Clarno, OR. Grass, sage and juniper. Minimal fire behavior. Last report unless significant activity occurs.

Malott, Northeast Region, Washington DNR. Two miles northwest of Malott, WA. Brush. Minimal fire behavior.

Foam Creek – WFU, Okanogan/Wenatchee NF. Thirteen miles northwest of Leavenworth, WA. Timber. Moderate fire activity with spotting. Area and trail closures in effect. Last narrative report unless significant activity occurs.

Minam Peak – WFU, Wallowa-Whitman NF. Twelve miles southwest of Joseph, OR. Timber and subalpine fir. Creeping and torching. Last narrative report unless significant activity occurs.
