2009 Winter Initial Attack, Texas Forest Service. Texas IMT 2 (Bennett). IMT is supporting multiple fires in west Texas. Acres reported are a cumulative total.

Peach Orchard, Osage Agency, BIA. Four miles north of New Prue, OK. Hardwood litter and grass. No new information.

Juniper Springs, National Forests in Florida. Nine miles east of Silver Springs, FL. Southern rough and downed heavy fuels. No new information. Last report unless new information is received.

Pretty Penny, Osage Agency, BIA. One mile southwest of Okesa, OK. Hardwood litter and grass. Precipitation occurred over the fire area yesterday.

Brickyard, National Forests in Florida. One mile south of Sumatra, FL. Southern rough. Active fire behavior.

Woody, Florida DOF. Nine miles north of Deltona, FL. Southern rough. Minimal fire activity.

Indian Lake, Florida DOF. Three miles west of Daytona Beach, FL. Southern rough. Minimal fire activity.

Old Fifty, Florida DOF. One mile southwest of Richloam, FL. Brush. Smoldering and creeping.

Brewster CMD, Florida DOF. Two miles west of Fort Meade, FL. Grass. Minimal fire activity. Precipitation occurred over the fire area yesterday.

Matanzas, Florida DOF. Three miles southwest of St. Augustine, FL. Southern rough. No further information received.

Stone Mountain, Cherokee NF. Three miles east of Unicio, TN. Hardwood litter. Smoldering.

Taylor Branch, Daniel Boone NF. Six miles southeast of Whitley City, KY. Hardwood litter. No further information received.
