**Stoney Ridge**, Eastern Cherokee Agency, BIA. IMT 2 (Wilder). IMT is also managing the Laurel Falls 2 fire. Eight miles northeast of Cherokee, NC. Pine, hemlock and hardwood litter. No new information.

**Laurel Falls 2**, Great Smoky Mountains NP. Four miles west of Gatlinburg, TN. Hardwood litter. No further information received.

**2009 Winter Initial Attack**, Texas Forest Service. Texas IMT 2 (Hanneman). IMT is supporting multiple fires in west Texas. Acres reported are a cumulative total.

**Harley**, Florida DOF. One mile northeast of Bithlo, FL. Hardwood litter. No further information received.

**Putnam / Georgetown**, Florida DOF. One mile southeast of Georgetown, FL. Southern Rough. No further information received.

**Canal**, Florida DOF. Five miles southwest of Oak Hill, FL. Southern rough. No further information received.

**Klayber**, Daniel Boone NF. Seven miles south of Frenchburg, KY. Hardwood litter. No new information. Last report unless new information is received.

### Spot Weather Forecast

Spot weather forecasts should be requested for those fires that have potential for extreme fire behavior, exceed initial attack, or are located in areas where Red Flag Warnings have been issued.

● Basic elements needed for a spot weather forecast include:

- Name of fire and management agency
- Request time and date
- Location by ¼ section
- Drainage name
- Exposure
- Size
- Elevation (top and bottom)
- Fuel type
- Fire character (ground, crown, etc.)
- Weather conditions (place, elevation, observation time, wind direction, wind velocity, dry bulb, wet bulb, remarks)
