Department of Interior personnel are assigned to several locations in the Gulf of Mexico to assess and mitigate impacts resulting from the Deepwater Horizon oil spill.

- A total of 328 Fish and Wildlife Service personnel are assigned to Delta, Breton and Bon Secour National Wildlife Refuges, as well as Houma, LA and Mobile, AL.

- A total of 209 National Park Service personnel are assigned to Gulf Islands National Seashore, Jean Lafitte Park and Preserve, Everglades National Park, Dry Tortugas, Biscayne National Park, De Soto National Memorial and Big Cypress National Preserve.

New, Carlsbad Caverns NP. Twenty miles west of White City, NM. Brush. Backing fire with isolated torching.

Eagle Trail, Tok Area Forestry, Alaska DOF. IMT 2 (Allen). One mile south of Tanacross, AK. Spruce. Active fire with spotting, running and torching. Village of Tanacross evacuated and numerous structures threatened. Traffic delays along Alaska Highway.

Toklat, Tanana Zone, BLM. Limited perimeter control incident. Started on state land 25 miles southwest of Nenana, AK. Black spruce and tundra. Running fire with long-range spotting. Residences and outbuildings threatened.

Applegate, Tanana Zone, BLM. Twenty-five miles northeast of Manley Hot Springs, AK. Dormant brush, slash and black spruce. Single tree torching with spotting. Numerous structures threatened.

Chitanatala, Fairbanks Area Forestry, Alaska DOF. Limited perimeter control incident. Twenty-six miles southeast of Tanana, AK. Black spruce. Extreme fire behavior. Structures threatened. Last report unless significant activity occurs.

Gilles Creek, Delta Area Forestry, Alaska DOF. Limited perimeter control incident. Twenty miles north of Delta, AK. Dormant brush, slash and black spruce. Very active fire behavior. Shaw Creek threatened.

Turquoise Lake, Southwest Area Forestry, Alaska DOF. Confine/contain incident. Fifteen miles southwest of Farewell, AK. Black spruce. Active fire behavior. Residences threatened. Last report unless significant activity occurs.

Cascaden Ridge, Tanana Zone, BLM. Previously reported limited perimeter control incident. Twelve miles southwest of Livengood, AK. Extreme fire behavior. Structures threatened. Last report unless significant activity occurs.

* **Slokenjikh**, Tanana Zone, BLM. Limited perimeter control incident. Forty miles north of Tanana, AK. No further information received. Last report unless significant activity occurs.

* **McClellan Creek**, Southwest Area Forestry, Alaska DOF. Confine/contain incident. One mile north of Cripple Landing, AK. No further information received. Last report unless significant activity occurs.

Fryingpan Creek, Upper Yukon Zone, BLM. Limited perimeter control incident. Twenty-two miles southwest of Central, AK. Black spruce, hardwood slash and brush. Backing fire with isolated torching. Last report unless significant activity occurs.

Mississippi Impact Area, Alaska Fire Service, Military Zone. Previously reported limited perimeter control incident. Ten miles southwest of Delta Junction, AK. Timber. Active fire behavior. Fire will continue to be monitored. Last report unless significant activity occurs.

* **Granite Tors**, Fairbanks Area Forestry, Alaska DOF. Confine/contain incident. Twenty-eight miles northeast of Moose Creek, AK. Hardwood, brush and tundra. Active fire behavior with crowning. Fire will continue to be monitored. Last report unless significant activity occurs.

Popavich, Fairbanks Area Forestry, Alaska DOF. Previously reported confine/contain incident. Seven miles northwest of Healy, AK. Black spruce. Running, torching and spotting. Structures threatened. Last report unless significant activity occurs.

* **North Fork**, Southwest Area Forestry, Alaska DOF. Confine/contain incident. One mile north of Soda Creek. Black spruce. No further information received. Last report unless significant activity occurs.

* **Sischu 2**, Tanana Zone, BLM. Confine/contain incident. Sixty miles south of Tanana, AK. No further information received. Last report unless significant activity occurs.

* **Sischu 1**, Tanana Zone, BLM. Confine/contain incident. Fifty-five miles south of Tanana, AK. No further information received. Last report unless significant activity occurs.

* **Reindeer River**, Southwest Area Forestry, Alaska DOF. Confine/contain incident. One mile north of Iditarod River, AK. Black spruce. Crown fire. Last report unless significant activity occurs.

South Fork Healy, Delta Area, Alaska DOF. Confine/contain incident. Forty miles east of Delta Junction, AK. Mixed spruce and hardwoods. Active fire behavior with running and spotting. Last report unless significant activity occurs.

* **South Schwatka**, Upper Yukon Zone, BLM. Limited perimeter control incident. Sixty-two miles north of Fairbanks, AK. No further information received. Last report unless significant activity occurs.

* **Lone Mountain**, Southwest Area Forestry, Alaska DOF. Confine/contain incident. One mile north of Lone Mountain, AK. Black spruce. Last report unless significant activity occurs.

Upper Gerstle, Delta Area Forestry, Alaska DOF. Confine/contain incident. Thirty miles southeast of Delta Junction, AK. Black spruce and mixed hardwoods. Creeping fire. Last report unless significant activity occurs.

Sheenjek 2, Upper Yukon Zone, BLM. Limited perimeter control incident. Started on Fish and Wildlife Service land 47 miles southeast of Arctic Village, AK. Black spruce and hardwood slash. Last report unless significant activity occurs.

Predictive Services Discussion: Significant fire potential with warm temperatures, low relative humidity and mixed wet and dry thunderstorms continues across central and eastern Alaska. Dry and breezy conditions will develop today across southwest Alaska. Low relative humidity will combine with gusty winds to elevate fire potential across New England. Winds will increase today across the Great Lakes as a storm system moves through the region, however scattered precipitation and increased relative humidity should limit fire potential. Gusty winds and low relative humidity may increase fire potential across portions of southern Colorado.

Are You "[FireFit](#)"?

- The FireFit program was created with the intent of providing the interagency wildland fire community with a comprehensive, easy-to-follow, fitness program with the ultimate goal of improving firefighter safety and health and reducing injuries. This program provides a basic format for a well balanced fitness program that can be augmented as local units see fit. Program success will rely on management support at every level as well as individual's motivation and participation.
- Fitness is defined as, "the body's ability to perform physical activity without distress or injury." Although most people rarely engage in arduous physical activity as part of their daily jobs, wildland firefighters know that physical fitness plays an important role in our personal wellness and job performance. It's a proven fact that by incorporating a balanced fitness program into our daily work life, we enhance our health and safety, while mitigating our risk of injury and illness and increasing our ability to do work.
- The following checklist will help to guide you in preparation for all levels of fitness activities:
 - Consult with your physician
 - Establish goals
 - Make the commitment to yourself and your crew
 - Get educated – the more you know, the healthier and safer you will be
 - Have the appropriate footwear and clothing for exercise
 - Adhere to your agency procedures for fitness and medical clearance
- In order to implement a balanced fitness program, it's important to include all of the essential components of fitness. When developing a fitness program, its good practice to incorporate the F.I.T. Prescription = Frequency, Intensity, and Time. Utilizing the F.I.T. Prescription allows you to exercise safely while achieving steady improvements.

In his book, "[Fitness and Work Capacity, 2nd Edition](#)," Dr. Brian Sharkey has developed an Aerobics Fitness Index (page 9) that provides a good calculation for determining your level of aerobic fitness which is based on your level of physical activity.
