Anderson's Area Command Team has been assigned to Rocky Mountain Geographic Area.

Waldo Canyon, Pike and San Isabel NF. IMT 1 (Harvey). Three miles west of Colorado Springs, CO. Timber, hardwood slash and brush. Several communities, municipal watersheds and the U.S. Air Force Academy threatened. No further information received.

High Park, Larimer County. IMT 1 (Lund). Fifteen miles west of Fort Collins, CO. Timber, brush and grass. Short duration crown runs with single and group tree torching. Subdivisions, communication tower and recreation sites threatened. Evacuations in effect.

Weber, San Juan District, BLM. IMT 2 (Lowe). Six miles south of Mancos, CO. Timber. Crown fire with torching and spotting. Numerous structures and communication towers threatened. Evacuations in effect.

Russels Camp, Medicine Bow NF. IMT 2 (Pechota). Thirty miles south of Glenrock, WY. Timber and brush. Moderate fire activity with short-range spotting. Structures threatened.

*** State Line**, La Plata County. Seventeen miles southwest of Ignacio, CO. Brush and hardwood slash. Moderate fire activity with isolated group tree torching. Road closures in effect.

Treasure, Pike and San Isabel NF. Five miles northeast of Leadville, CO. Timber. Minimal fire activity with occasional torching. Structures threatened.

Little Sand, San Juan NF. NIMO (Kleinman). Thirteen miles northwest of Pagosa Springs, CO. Timber. Occasional torching and short-range spotting. Structures threatened. Evacuations in effect.

Predictive Services Discussion: Strong winds and hot and dry conditions will continue across the Great Basin and the central Rockies. Scattered thunderstorms will continue in eastern Utah and western Colorado with scattered showers and thunderstorms over northern Arizona and New Mexico. Scattered showers and a few thunderstorms will move through the Northwest and the northern Rockies. Cooler weather will move across the East, with scattered showers and thunderstorms developing along the mid-Atlantic and Northeast coasts. Thunderstorms will increase across the Gulf states as tropical activity persists. In Alaska, shower activity will spread across the west and south. Isolated thunderstorms are still possible in the Interior.

Fatigue/Stress

Accumulated (Chronic) Fatigue is defined as fatigue from which normal rest does not produce recovery. Accumulated fatigue is often caused by extended periods of stress with inadequate recovery periods, which results in decreased productivity, compromised immune function, and reduced alertness. Fatigued workers perform poorly, behave carelessly, tolerate greater errors and become inattentive. Chronic fatigue often results in increased stress, which may present itself through certain behavioral and physiological indicators, such as those described below:

- Behavioral indicators
 - Decreased motivation and low morale
 - Increased irritability and depression

- Physiological indicators
 - Confused, poor problem solving
 - Poor abstract thinking
 - poor attention/decisions
 - poor concentration/memory
 - extreme emotional responses
 - social/behavioral changes

- Recommendations for chronic fatigue/stress are:
 - Take longer periods of rest/recovery
 - Ensure that workers are adequately rested before they begin work shifts
 - Provide periodic rest breaks to allow physical and mental recovery
 - Alternate between heavy and light tasks
 - Eat well-balanced meals regularly, with energy supplements during periods of high exertion
 - Maintain hydration
 - Ensure workers maintain good personal hygiene
 - Maintain high standards of physical fitness and work capacity
 - In extreme cases, personnel may need to be relieved of their duties
