Table Mountain, Okanogan/Wenatchee NF. IMT 1 (Morcom). Eight miles northeast of Cle Elum, WA. Timber, logging slash, brush and grass. Smoldering. Numerous structures threatened. Evacuations and area closures in effect.

Wenatchee Complex (6 fires), Okanogan/Wenatchee NF. IMT 1 (Reinarz). Two miles west of Wenatchee, WA. Timber, brush and grass. Active fire behavior with spotting. Numerous residences threatened.

Cascade Creek, Gifford Pinchot NF. IMT 2 (Nickey). Eight miles north of Trout Lake, WA. Timber. Active fire behavior with torching.

Pole Creek, Deschutes NF. Six miles southwest of Sisters, OR. Timber. Active fire behavior.

Predictive Services Discussion: Temperatures will be 10 to 25 degrees colder across the Northwest, northern Rockies and northern Plains as a strong cold front drops into the U.S. from Canada. Scattered rain with snow at higher elevations will spread from western Montana and Wyoming to northern Minnesota. Windy conditions ahead of and immediately behind the cold front will produce near critical fire weather conditions over parts of the Northwest, the Great Basin and the central Plains. The East will be warmer, with hot conditions developing in the southern Plains. Scattered showers and a few thunderstorms will move through the Upper Mississippi and Ohio Valleys. Scattered thunderstorms will form across Florida.

OPERATIONAL BRIEFINGS

Operational briefings are critical to safe fire operations. To ensure a consistent and effective briefing, a standardized briefing checklist should always be used. The following checklist is printed on the cover of the NWCG Incident Response Pocket Guide:

● Situation:

- Fire name, location, map orientation, other incidents in the area
- Terrain influences
- Fuel type and conditions
- Fire weather (previous, current, and expected)
- Fire behavior (previous, current, and expected)

● Mission/Execution:

- Command (Incident Commander/immediate supervisor)
- Leader's intent
- Specific tactical assignments
- Contingency plans

● Communications:

- Communication Plan (tactical, command, air/ground frequencies, cell phone numbers, etc.)
- Medevac Plan

● Service/Support:

- Other resources that may be working adjacent to you and those available to order
- Aviation operations
- Logistics (e.g., transportation, supplies, equipment)

● Risk Management:

- Identify known hazards and risks
- Identify control measures to eliminate hazards and reduce risk
- Identify trigger points for disengagement or reevaluation of operational plan
