Four MAFFS C-130 Airtankers are assigned to McClellan Airfield in Sacramento, California in support of wildland fire operations. Two aircraft are provided by the 302nd Airlift Wing, Colorado Springs, Colorado. One aircraft is provided by the 153rd Airlift Wing, Cheyenne, Wyoming. One aircraft is provided by the 145th Airlift Wing, Charlotte, North Carolina.

Five wildland fire suppression crews from Ontario, Canada and one Convair 580 airtanker group from both Saskatchewan and Alberta are supporting fire suppression efforts in the Northern Rockies.

Area Command Team (Walker) is assigned to the Colville National Forest for large fire support.

Canyon Creek Complex (2 fires), Malheur NF. IMT 1 (Lund). Two miles south of John Day, OR. Timber, medium logging slash and short grass. Moderate fire behavior with crowning, running and torching. Numerous structures threatened. Road, area and trail closures in effect.

Reach (3 fires), Spokane District, BLM. IMT 1 (Schulte) and IMT 1 (Templin). IMT is also managing the Black Canyon, First Creek, McFarland Creek, Wolverine and Blankenship fires. One mile south of Chelan, WA. Timber and short grass. Moderate fire behavior with torching and backing. Numerous structures threatened. Evacuations and road closures in effect.

Black Canyon, Okanogan-Wenatchee NF. Eight miles west of Pateros, WA. Timber, closed timber litter and brush. Active fire behavior with crowning, torching and backing. Evacuations and road closures in effect.

First Creek, Okanogan-Wenatchee NF. Eight miles northwest of Chelan, WA. Timber, closed timber litter and brush. Active fire behavior with short crown runs, torching and running. Numerous structures threatened. Evacuations and road closures in effect.

McFarland Creek, Okanogan-Wenatchee NF. Eight miles west of Pateros, WA. Timber and closed timber litter. Active fire behavior with torching, short crown runs and backing. Structures threatened. Road closures in effect.

Wolverine, Okanogan-Wenatchee NF. Three miles northwest of Lucerne, WA. Timber and brush. Moderate fire behavior with spotting, backing and creeping. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

Blankenship, Okanogan-Wenatchee NF. Fifteen miles northwest of Lucerne, WA. Timber and brush. No new information. Last report unless new information is received.

Okanogan Complex (4 fires), Northeast Region, DNR. IMT 1 (Pechota) and IMT 2 (Rabe). Eleven miles northwest of Omak, WA. Timber. Extreme fire behavior with torching, spotting and wind-driven runs. Structures threatened. Evacuations and road closures in effect.

Carpenter Road, Northeast Region, DNR. IMT 2 (Esperance). Five miles south of Fruitland, WA. Timber. Extreme fire behavior with torching, crowning and uphill runs. Numerous structures threatened. Evacuations and road closures in effect.

North Star, Colville Agency, BIA. IMT 2 (Nieto). Twenty-four miles east of Omak, WA. Timber and light logging slash. Extreme fire behavior with group torching, spotting and uphill runs. Numerous structures threatened. Evacuations, road and area closures in effect.

Eagle, Wallowa-Whitman NF. IMT 2 (Greer). Twenty miles northwest of Richland, OR. Timber and medium logging slash. Active fire behavior with group torching, single tree torching and spotting. Structures threatened. Road, area and trail closures in effect.

* **Kaniksu Complex (2 fires)**, Colville NF. IMT 2 (Tom Kurth). Includes previously reported Tower and Baldy fires. Ten miles northeast of Usk, WA. Timber and logging slash. Active fire behavior with single tree torching, spotting and running. Structures threatened. Road, area and trail closures in effect.

Cornet-Windy Ridge, Vale District, BLM. IMT 1 (Ruggerio). Four miles west of Durkee, OR. Timber and short grass. Moderate fire behavior with uphill runs, flanking and backing. Numerous structures threatened. Evacuations and road closures in effect.

Eldorado, Vale District, BLM. ODF IMT 1 (Smith). Started on private land five miles southeast of Unity, OR. Timber, brush and tall grass. Moderate fire behavior with short-range spotting. Structures threatened.

National Creek Complex (2 fires), Rogue River-Siskiyou NF. IMT 1 (Lewis). Eleven miles southwest of Diamond Lake, OR. Timber and closed timber litter. Active fire behavior with group torching, short-range spotting and flanking. Numerous structures threatened. Road, area and trail closures in effect.

Stouts Creek, South Unit, ODF. ODF IMT 1 (Cline). Sixteen miles east of Canyonville, OR. Timber. Active fire behavior with single tree torching and backing. Numerous structures threatened. Road and area closures in effect.

County Line 2, Warm Springs Agency, BIA. IMT 2 (Sheldon). Six miles northwest of Warm Springs, WA. Timber and brush. Active fire behavior with group torching, spotting and running. Numerous structures threatened. Evacuations, area and trail closures in effect.

Cougar Creek, Yakama Agency, BIA. IMT 2 (Leitch). Six miles northwest of Glenwood, WA. Timber, medium logging slash and tall grass. Active fire behavior with torching, short-range spotting and flanking. Structures threatened. Road, area and trail closures in effect.

Bendire Complex (2 fires), Vale District, BLM. IMT 2 (Goff). Fifteen miles north of Juntura, OR. Timber, brush and short grass. Minimal fire behavior with smoldering. Structures and sage-grouse habitat threatened. Area closure in effect.

Collier Butte, Rogue River-Siskiyou NF. IMT 2 (Johnson). Eighteen miles east of Gold Beach, OR. Timber and brush. Moderate fire behavior with short crown runs, flanking and backing. Structures threatened. Road, area and trail closures in effect.

Stickpin, Colville NF. IMT 2 (Ciraulo). IMT is also managing the Graves and Roy fires. Fifteen miles northeast of Republic, WA. Timber, hardwood slash and dormant brush. Active fire behavior with short crown runs, group torching and spotting. Numerous structures threatened. Evacuations in effect. Reduction in acreage due to more accurate mapping.

* **Graves**, Colville NF. Eighteen miles east of Republic, WA. Timber, brush and grass. Active fire behavior with group torching, spotting and short crown runs. Numerous structures threatened. Evacuations in effect.

Roy, Northeast Region, DNR. Five miles west of Republic, WA. Timber, hardwood slash and dormant brush. Moderate fire behavior with flanking, creeping and smoldering. Structures threatened.

Gold Hill, Northeast Region, DNR. One mile north of Kettle Falls, WA. Timber. Active fire behavior with isolated torching, short-range spotting and flanking. Structures threatened. Road closure in effect.

Grizzly Bear Complex (8 fires), Umatilla NF. NIMO (Hahnenberg). Previously reported incident. Twenty miles southeast of Dayton, WA. Timber. Active fire behavior with group torching and short crown runs. Structures threatened. Road, area and trail closures in effect.

Marble Valley, Northeast Region, DNR. IMT 2 (Fillis). Three miles northeast of Addy, WA. Timber. Moderate fire behavior with spotting, backing and creeping. Numerous structures threatened. Evacuations and road closures in effect.

Cable Crossing, Central Unit, ODF. Six miles east of Glide, OR. Timber, medium logging slash and brush. No new information.

Rutter Canyon, Northeast Region, DNR. Two miles north of Spokane, WA. Timber. No new information.

Phillips Creek, Umatilla NF. Seven miles northwest of Elgin, OR. Timber and short grass. No new information.

Thursday Creek, North Cascades NP. Twenty miles southwest of Manning Park, WA. Timber. No new information. Last report unless new information is received.

* **Municipal Complex**, Clearwater Potlatch Timber Protective Association. IMT 1 (Wilkins). Includes previously reported Municipal fire. One mile east of Orofino, ID. Timber. Moderate fire behavior with backing, creeping and smoldering. Structures threatened. Area and road closures in effect.

Clearwater Complex (6 fires), Nez Perce - Clearwater NF. IMT 1 (Poncin) and IMT 2 (Staats). Started on state land one mile northwest of Kamiah, ID. Timber, hardwood slash and dormant brush. Active fire behavior with group torching and uphill runs. Numerous structures threatened. Road, area and trail closures in effect.

Northeast Kootenai Complex, Kootenai NF. IMT 2 (Pearson). IMT is also managing the Weigel fire. Four miles northwest of Trego, MT. Timber. Active fire behavior with group torching and short crown runs. Numerous structures threatened.

Weigel, Northwestern Land Office, DNR. Twenty-four miles northeast of Libby, MT. Timber. Minimal fire behavior with single tree torching.

Thompson Divide Complex, Glacier NP. IMT 2 (Leach). Three miles southwest of Essex, MT. Timber. Moderate fire behavior. Structures threatened. Area and trail closures in effect.

Sucker Creek, Helena NF. IMT 2 (Bales). Six miles northeast of Lincoln, MT. Timber. Moderate fire behavior with isolated torching, creeping and backing. Structures threatened. Road, area and trail closures in effect.

Morrell Complex (2 fires), Lolo NF. IMT 2 (Grant). Seven miles north of Seeley Lake, MT. Timber and closed timber litter. Active fire behavior with group torching, short-range spotting and backing. Road, area and trail closures in effect.

Trail Creek, Flathead NF. Previously reported incident. Nineteen miles east of Swan Lake, MT. Timber. Active fire behavior with torching, uphill runs and backing. Numerous structures threatened. Road, trail and area closures in effect. Last report unless significant activity occurs.

Not Creative, Cataldo Area Office, IDL. IMT 2 (Fry). Started on private land 15 miles north of St. Maries, ID. Timber. Minimal fire behavior with creeping and smoldering.

Scotchmans Gulch, Beaverhead - Deerlodge NF. IMT 2 (Thompson). Fifteen miles northwest of Philipsburg, MT. Timber. Minimal fire behavior with smoldering.

Marble Creek, Idaho Panhandle NF. Seven miles southeast of Avery, ID. Timber. Moderate fire behavior with single tree torching and spotting.

Melton 1, Flathead Agency, BIA. Eight miles north of Dixon, MT. Timber. Moderate fire behavior with isolated torching and creeping. Structures threatened.

Parker Ridge, Idaho Panhandle NF. Seven miles southwest of Porthill, ID. Timber. Active fire behavior with uphill runs and backing. Structures threatened. Evacuations, road, area and trail closures in effect

Elk City Complex, Nez Perce - Clearwater NF. Nineteen miles southeast of Syringa, ID. Timber and medium logging slash. No new information. Last report unless significant activity occurs.

Trophy Ridge, Fergus County. Fifteen miles east of Roy, MT. Timber. Moderate fire behavior with creeping. Structures threatened.

Big Lost, Ponderosa Area Office, IDL. Twenty-five miles north of Moscow, ID. Timber and heavy logging slash. Moderate fire behavior with isolated torching and creeping. Structures threatened. Road, area and trail closures in effect.

Napoleon 1 (3 fires), Kootenai NF. Five miles north of Noxon, MT. Timber. Active fire behavior with torching and flanking. Structures threatened. Road, area and trail closures in effect.

Cabin Creek, Central Land Office, DNR. Started on BLM land 10 miles east of Dillon, MT. Brush and short grass. Minimal fire behavior with creeping and smoldering. Reduction in acreage due to more accurate mapping.

Fork Complex (5 fires), Shasta-Trinity NF. Unified command between IMT 1 (McGowan) and Cal Fire. Three miles east of Hayfork, CA. Timber, light logging slash and chaparral. Moderate fire behavior with single tree torching, creeping and backing. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

South Complex (3 fires), Shasta-Trinity NF. IMT 2 (Young). Five miles north of Hyampom, CA. Timber. Active fire behavior with group torching, spotting and backing. Numerous structures threatened. Road, area and trail closures in effect.

Mad River Complex (3 fires), Six Rivers NF. IMT 1 (Turman). IMT is also managing the Route Complex. Eight miles south of Mad River, CA. Timber, chaparral and tall grass. Active fire behavior with group torching, spotting and backing. Numerous structures threatened. Road, area and trail closures in effect.

Route Complex (2 fires), Six Rivers NF. Six miles north of Hyampom, CA. Timber, chaparral and tall grass. Active fire behavior with uphill runs, single tree torching and group torching. Numerous structures threatened. Area and trail closures in effect.

River Complex, Shasta-Trinity NF. IMT 1 (Ourada). Three miles southwest of Denny, CA. Timber, chaparral and tall grass. Active fire behavior with isolated torching, flanking and backing. Structures threatened. Evacuations, road, area and trail closures in effect.

Nickowitz, Six Rivers NF. IMT 2 (Jay Kurth). Fifteen miles west of Somes Bar, CA. Timber, chaparral and tall grass. Active fire behavior with group torching, short-range spotting and backing. Structures threatened. Road, area and trail closures in effect.

Gasquet Complex (6 fires), Six Rivers NF. IMT 2 (Nunez). Thirteen miles northeast of Crescent City, CA. Timber, brush and tall grass. Active fire behavior with single tree torching, running and backing. Structures threatened. Road, area and trail closures in effect.

Predictive Services Discussion: An upper level ridge of high pressure over the southwest quarter of the Nation will keep conditions very hot and dry today while a thermal trough will provide unstable conditions in the Pacific Northwest. Elsewhere over the Intermountain West it will be breezy in the Rockies with showers and thunderstorms developing over the adjacent High Plains. A strong upper level trough over the Great Lakes region will bring a cold front to focus scattered thunderstorms with heavy rain and gusty winds all the way south into the southern Plains. Much-needed rainfall is also expected along a cold front draped from the Gulf Coast through the Mid-Atlantic region.

CHAINSAW SAFETY

Felling Safety Category

Chainsaw safety is every saw operator's job.

- Always wear proper P.P.E. when handling or working around chainsaws.
 - Eye protection- approved goggles or safety glasses (no sunglasses)
 - Chainsaw Chaps- proper size and length
 - Gloves-proper size
 - Long sleeve shirt-no loose sleeves
 - Leather boots-no loose boot laces

- Take the time to inspect the chainsaw before operating the saw.
 - Check the chain and bar- Sharpness of chain, Bar seated correctly
 - Check the bolts and screws all around the saw- no missing screws or bolts
 - Check the casing of the saw- no cracked or missing plastic

- Make sure you're aware of your surroundings while operating the chainsaw.
 - Check the chain and bar- Sharpness of chain, Bar seated correctly
 - Check the bolts and screws all around the saw- no missing screws or bolts
 - Check the casing of the saw- no cracked or missing plastic

- Make sure you're aware of your surroundings while operating the chainsaw.
 - Look for people working in your area- advise all personnel you're operating the saw.
 - Look for any snags or hazards in your area- look up for power lines, widow makers, etc.
 - Make sure you always have a spotter or swamper to use for communications.
 - Always watch your footing while operating the saw- loose, rocky, steep terrain can cause you to slip while the chainsaw is running.

- Always make sure you are comfortable doing the task at hand.
 - Proper training for personnel running saws.
 - While falling trees know your escape route.
 - If you are not comfortable falling the tree walk away. Notify your supervisor and mitigate the safety issues or turn down the assignment.
