One MAFFS C-130 air tanker and support personnel each from the 153<sup>rd</sup> Airlift Wing, (Wyoming Air National Guard) and the 302<sup>nd</sup> Airlift Wing, (Colorado Springs, Air Force Reserve) have been deployed to Boise, ID in support of wildland fire operations.

One Convair 580 airtanker group from British Columbia has been deployed to Pocatello, Idaho in support of wildland fire operations.

**Soberanes**, San Benito-Monterey Unit, Cal Fire. IMT 1 (Kurth). Seven miles northwest of Big Sur, CA. Timber, chaparral and tall grass. Active fire behavior with running, spotting and flanking. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

**Chimney**, San Luis Obispo Unit, Cal Fire. Transfer of command from Cal Fire IMT 1 (Patterson) back to the local unit will occur tomorrow. Fifteen miles west of Paso Robles, CA. Timber and chaparral. Active fire behavior with backing, creeping and smoldering. Structures threatened.

**Cedar**, Sequoia NF. Transfer of command from IMT 1 (Minton) to IMT 2 (Laeng) will occur tomorrow. Five miles north of Alta Sierra, CA. Timber and chaparral. Moderate fire behavior with isolated torching, creeping and smoldering. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

**Rey**, Los Padres NF. Transfer of command from IMT 1 (McGowan) back to the local unit will occur today. Seven miles north of Goleta, CA. Chaparral. Minimal fire behavior. Road, area and trail closures in effect.

**Pioneer**, Boise NF. Transfer of command from IMT 1 (Lund) to IMT 1 (Martin) will occur tomorrow. Eight miles north of Idaho City, ID. Timber. Extreme fire behavior with running, spotting and torching. Structures threatened. Road, area and trail closures in effect.

**Berry**, Grand Teton NP. IMT 2 (Roide). Nineteen miles northwest of Moran, WY. Timber and short grass. Active fire behavior with short crown runs, torching and flanking. Structures threatened. Evacuations, road, area and trail closures in effect.

**Tie**, Caribou-Targhee NF. IMT 2 (Bird). Ten miles southwest of Victor, Idaho. Timber and brush. Moderate fire behavior with single tree torching, flanking and creeping. Structures threatened. Road, area and trail closures in effect.

**Peterson Hollow**, Uinta/Wasatch-Cache NF. Twelve miles northwest of Garden City, UT. Timber. Moderate fire behavior with spotting, torching and backing. Structures threatened. Road, area and trail closures in effect.

**Predictive Services Discussion:** Scattered thunderstorms will continue across the southern and central Rockies and across Texas. Isolated thunderstorms will form over the northern Rockies and the Great Basin. Showers will continue along the Northwest Coast. Rain and thunderstorms associated with a tropical storm will continue across the Southeast and Mid Atlantic. Temperatures will be mild to cool across the Midwest and New England while the northern Plains and the Southeast remain warm. Mild to cool weather will spread across the Northwest and the Rockies while hot conditions remain in the desert Southwest.

# LEAD Time

## Command Presence

*Leadership Category*

Leaders often face difficult problems to which there are no simple, clear cut, by-the-book solutions. In these situations, leaders must use their knowledge, skill, experience, education, values, and judgment to make decisions and take or direct action. Command Presence is one element of a leader's effectiveness.

Command Presence is how leaders present themselves to others. More than anything else, the leader's Command Presence sets the tone for the Command Climate within an organization. *(Command Climate refers to the environment within the influence of a particular leader and a good command climate is characterized by open communication, mutual trust and respect, freedom to raise issues and engage in debate, clear and attainable goals, and team-work.)*

Character is the foundation of Command Presence. Leaders reveal their character in every interaction. Leaders must display a combination of personal attributes and behaviors that communicate to others that you are worthy of their trust and respect.

Another component of Command Presence—demeanor—speaks volumes to others. Poise and self-assurance play a large part in your ability as a leader to influence the actions of others.

Fire leaders take charge when in charge, lead from the front and act decisively in order to inspire confidence among team members. In times of crisis, a leader's Command Presence can be the critical factor in determining whether a team succumbs to pressures and dangers or stays focused to seize an opportunity to overcome and succeed
