**Soberanes**, San Benito-Monterey Unit, Cal Fire. IMT 1 (Kurth). Seven miles northwest of Big Sur, CA. Timber, chaparral and tall grass. Active fire behavior with flanking, backing and smoldering. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

**Chimney**, San Luis Obispo Unit, Cal Fire. Transfer of command from Cal Fire IMT 1 (Patterson) back to the local unit will occur today. Fifteen miles west of Paso Robles, CA. Timber and chaparral. Moderate fire behavior with backing, creeping and smoldering. Structures threatened.

**Cedar**, Sequoia NF. Transfer of command from IMT 1 (Minton) to IMT 2 (Laeng) will occur today. Five miles north of Alta Sierra, CA. Timber and chaparral. Minimal fire behavior with isolated torching, creeping and smoldering. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

**Rey**, Los Padres NF. Seven miles north of Goleta, CA. Chaparral. Minimal fire behavior. Road, area and trail closures in effect.

**Pioneer**, Boise NF. Transfer of command from IMT 1 (Lund) to IMT 1 (Martin) will occur on 9/4. Eight miles north of Idaho City, ID. Timber. Extreme fire behavior with running, spotting and group torching. Structures threatened. Road, area and trail closures in effect.

\* **Maggie**, Northern Region, Nevada DOF. Eighteen miles north of Carlin, NV. Brush and tall grass. Extreme fire behavior with wind driven runs and flanking. Structures threatened. Area closures in effect.

**Berry**, Grand Teton NP. IMT 2 (Roide). Nineteen miles northwest of Moran, WY. Timber and short grass. Moderate fire behavior with torching, flanking and creeping. Structures threatened. Evacuations, road, area and trail closures in effect.

**Maple**, Yellowstone NP. IMT 2 (Hutton). Four miles northeast of West Yellowstone, MT. Timber and grass. Active fire behavior. Structures threatened. Road, area and trail closures in effect.

**Predictive Services Discussion:** Scattered rain and snow showers will develop over the mountains of the Northwest and the Northern Rockies. Scattered thunderstorms will continue across the Four Corners region and into the Texas. Strong winds will continue across the Great Basin and the northern Rockies. ## INSTRUCTIONS AND ASSIGNMENTS NOT CLEAR

*Fire Communications Category*

Every firefighter will be giving and receive briefings at some point on the job. Briefings are an effective way to disseminate information that can make the firefighter's job safer and easier. When giving a briefing, it is important to keep the following questions in mind and remain perceptive to how the audience is receiving the information:

- Did you use the Incident Response Pocket Guide standards briefing checklist?
- Did they ask questions? Talk about what it is like giving a briefing. Do you get empty stares? What feedback are you looking for to ensure they understand you?
- Did they take notes? What kind of information would you like to see people write down?
- Did they repeat information back? What other ways can you identify that your briefing is registering?
- Did you give all the necessary information? How will you ensure that you covered everything necessary?
  - Task
  - Location
  - Communications
  - Hazards
  - Who, when, etc.
- It is also important for the firefighter who is receiving instructions to be mindful of the following during the briefing:
  - Did you really listen? What do you do to make yourself pay attention to everything being said?
  - Did you understand the assignment, location, and the nature and location of hazards? Do you expect to figure it out for yourself when you get out there or do you step forward and ask questions?
- You must know the location of the assignment and:
  - What is to be done?
  - Who you are to report to and how often to report.
  - When you are expected to complete the assignment.
  - Hazards.
  - Communication plan frequencies.
  - Weather and fire behavior.
  - Status of adjoining forces.
